At the time of issuing this declaration, no harmonized standards or common specifications pursuant to Art. 36/37 of Regulation (EU) 2025/40 are available. Conformity was assessed based on internal testing and material data sheets provided by suppliers.

H - Notified Body

Not applicable. The conformity assessment was carried out under Module A (Internal Production Control) in accordance with Annex VII of Regulation (EU) 2025/40.

I - Declaration of Conformity

The signatory declares that all materials used for the packaging units mentioned above comply with the requirements of the PPWR (EU) 2025/40 on packaging and packaging waste in accordance with the following provisions:

Article 5 Paragraph (4) – Lead, Cadmium, Mercury and Hexavalent Chromium:

The sum of the concentrations of lead, cadmium, mercury and hexavalent chromium present in packaging or packaging components is below the limit of 100 mg/kg.

Article 5 Paragraph (5) – Per- and Polyfluoroalkyl Substances (PFAS):

PFAS in food contact packaging are below the limit values set out in Article 5.
